THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/947 of the European Parliament and of the Council of 9 June 2021 establishing the Neighbourhood, Development and International Cooperation Instrument – Global Europe, amending and repealing Decision No 466/2014/EU and repealing Regulation (EU) 2017/1601 and Council Regulation (EC, Euratom) No 480/2009², and in particular Article 23(6) thereof,

Whereas:

- (1) By its decision C(2023) 1308 of 24.2.2023, the Commission has adopted an exceptional assistance measure regarding Ukraine.
- (2) Due to the large scale of contamination with mines and other explosive remnants of war in Ukraine as a result of Russia's illegal war of aggression, a significant increase in humanitarian demining capacities is needed, to which the additional equipment to be provided by means of this top-up will contribute significantly. The new total amount of the measure is increased to EUR 20 790 000.
- (3) Commission Decision C(2023) 1308 of 24.2.2023 should therefore be amended accordingly.
- (4) This amending decision is in accordance with the opinion of the Committee established under Article 45 of Regulation (EU) 2021/947.

HAS DECIDED AS FOLLOWS:

Sole Article

Commission Implementing Decision C(2023) 1308 of 24.2.2023 on an exceptional assistance measure regarding Ukraine is amended as follows:

(1) Article 2, first paragraph, is replaced by the following:

"The maximum Union contribution for the implementation of the measure is set at EUR 20 790 000 and shall be financed for an amount of EUR 20 000 000 from the appropriations entered in the budget line budget line 14 02 03 10 of the general budget of the Union for 2023 and for an amount of EUR 790 000 from the appropriations entered in the budget line budget line 14 02 03 10 of the general budget of the European Union for 2024."

(2) The Annex attached to the original Commission Decision C(2023) 1308 of 24.2.2023 is replaced by the Annex to this amending Decision.
